(G) Delivery / Payment Terms

a) Newton Classes offers Live Online Packages for different streams *e.g.* Maths and Physics (Year 9 and 10). You can visit our website for the list of Online Packages. Live online classes are delivered by our expert faculty / consultants.

Standard fee Structure for Live Online Classes -

- For Year 5 to 8 students: A\$25/hour
- For Year 9 and 10 students: A\$30/hour
- For Year 11 and 12 students: A\$35/hour
- b) Students / parent can buy Online Package(s) any time as per their requirement, by selecting any of the three payment options 10 Classes, 5 Classes, 2 Classes. Access to attend online classes will only be granted once the payment for those classes have been paid / processed.
- c) Validity of the Online Package- Online packages will expire according to the following criteria-
 - 10 Classes: 90 days from the date of purchase
 - 5 Classes: 45 days from the date of purchase
 - 2 Classes: 21 days from the date of purchase
- (d) On a successful payment, the payee will receive a confirmation email with a receipt for their payment.
- d) Newton Classes offers **FREE** live online classes regularly so that students can get familiar with the delivery process, the live streaming technology and their device compatibility with the online

delivery mechanism of our services. Students are strongly advised to attend FREE live online class (s) before buying any Online Package.

(H) Refund Policy

- (a) Students / parent can seek their full refund / partial refund, if they have paid the tuition fee in advance by buying a package. The amount, calculated as per the refund policy, will be processed within 5 business days from the date refund-request is received by email. Refund requests should be sent to newtonclasses.hotmail.com. Generally it can take 8 to 10 business days to appear on your bank statement.
- (b) Refund amount will be calculated based upon the standard fee structure, excluding the discount offered.

Example:

Normal tuition fee for Live Online Package for Year 9 is \$30/hour and it is \$45 for a 1.5 hour class. If someone buys a package of 10 classes upfront, discounted price of \$18/hr will be applied and a year 9 students will pay \$270 in advance for 10 live online classes (each class is of 1.5 hour duration). During the validity period of this package if a student decides to leave the online newton classes after attending 4 online classes, then an amount of 4 x 45 = \$180 will be charged and A\$90 will be refunded [calculated as fee 4x45 = 180; refund amount = 270 - 180 = \$90} while considering the normal tuition fee for 4 lessons.

- (c) Newton Classes have given an option to a payee to seek refund anytime during the validly period of a package. Once the package is expired or after attending all the online classes as part of that package, payee will not be entitled to receive any refund.
- (d) Full refunds will be offered for the services with major faults / defects occurred with Newton Classes due to technical reasons *e.g.* internet failure, cyber hack, etc.
- (e) If any student is unable to attend the live online classes due to IT / device issues at their end *e.g.* internet speed, obsolete browsers, incompatible operating system, etc.; No Refund will be offered from Newton Classes as we are not responsible for these issues.
- (f) As soon as a student book an online lass, they receive an email / sms for the confirmation of their booking. If a student has booked an online class and forgets to attend that class or could not attend that online class due to any reasons, best known to them, no refund for that particular class will be offered / processed.

(I) Mobile Phone Policy

It is found that usages of mobile phones during the classes are distracting and can impact the concentration / focus of other students in the class. Therefore the use of mobile phones in the class is prohibited specially browsing social media contents, messaging, tweeting, etc. However, mobile phones can be used for any emergency or important calls *e.g.* calling to parents for pick arrangements, etc.

Students attending the classes are not permitted to take photographs, video or record images or voices of other students or staff. Students or any other person available in the center are not permitted to take any photographs of books / documents / literature / IT devices available in the center.

Staff of Newton Classes can ask any student not using the phone during the class or can ask the students keeping their phone in their bags. Loss or damage of their mobile phones is solely their responsibility.

(J) Live Streaming and Recording Classes-

- (a) If it is found that any student is using unacceptable / abusive language and displays unacceptable photos, music, media during the live class or write unacceptable messages in the Chat box (conversation box), Newton Classes / presenter has full right to log-off / cancel that attendee from that class with immediate effect and the fee for that particular class will not be refunded. If a student repeats the same behavior in subsequent class(s), Newton Classes will terminate his package expiry date and refund the balance as per the refund policy when a student choose to terminate their package during the validity period.
- (b) Newton Classes record some online classes and make available those recorded sessions on their website / an appropriate platform or application so that attendees can refer to / listen to those lessons until the expiry of their package. Attendees must not make any attempt to alter / update / forward / download / copy these recorded lessons otherwise their access to recorded lessons can be revoked.
- (c) Attendee must follow the instructions of the presenter to use Microphone, Chat Box conversation, Video calls during the live class.
